The ARCC Conference is Canada's only applied cancer control research conference, bringing together policy & decision makers, researchers, clinicians, trainees, and other stakeholders to share work in the areas of health economics, services, policy, and ethics as it relates to cancer control in Canada. Presentation Formats

There will be two presentation formats: oral and poster. You may pre-select the format, however, abstracts submitted for consideration as oral presentations will subsequently be considered for poster presentations if not accepted for oral.

Please note that all posters must be printed in portrait style to fit the poster boards. Poster boards are 8ft tall and 4ft wide, including the frame. *Posters should be printed to a maximum width of 45"*.

Abstract Submission Content Guidelines

The online process will collect contact information for the presenter and co-authors, sources of funding, and whether the submission represents a student's project. Please note that the system will only allow entering of up to 10 co-authors. Should you need to add additional co-authors, please contact Brandy Beecroft by email at brandy@f2fe.com

The abstract submitted should not exceed 325 words and should not include authors and organizations in the text.

Instructions, Guidelines & Important Information

Please read the information below carefully

- Proposals for presentations of either format (oral or poster) must identify the presenting author(s) as the main contact. The presenting author information should not be included in the content of the abstract itself.
- The 2020 ARCC Conference will be accepting abstract submissions in both official languages (English and French).
 - o Abstracts accepted into the conference as posters may be presented in either English or French.
 - Abstracts accepted into the conference as oral presentations must be presented in English.

Note: All plenary sessions at the conference will be presented in English.

- All presenters accepted through the abstract submission process and/or presenting at the conference
 must register for and pay to attend the conference, and are responsible for their own related expenses. In
 addition, if the accepted presenter invites additional speakers to present with them at the conference,
 they must also register for and pay to attend the conference. Travel and accommodation costs will not be
 covered.
- All abstracts must be submitted using ARCC's online abstract submission process.
- There is no limit to the number of abstracts an author may submit; however, the number of accepted oral presentations may be limited for each presenter. Groups of authors are therefore encouraged to share presenting responsibilities.

- Accepted abstracts will be published in the conference program which will be distributed to the
 conference delegates and presentations will be made available electronically on the ARCC website
 following the conference.
- Abstract submissions should be for research that is either complete or will be complete by the conference date.
- Names of authors and organizations must not appear in the text of the abstract.
- The text should appeal to ARCC's interdisciplinary membership of decision makers, clinicians, researchers, and trainees.
- Avoid specialized jargon and undefined abbreviations. Do not include tables, figures, diagrams, footnotes, references, or acknowledgements in the text of the abstract.
- More details regarding registration as an abstract presenter will be provided upon acceptance of the abstracts for the conference.
- The conference office will aim to meet all reasonable requests for audio-visual equipment, based on the type and duration of the presentation. Upon acceptance, the conference secretariat will confirm audio visual details for your presentation.
- Please be sure to note specific requirements or considerations when submitting your abstract online.
- Please do not submit your title or abstract using only capital letters. These will be automatically corrected which may lead to errors.

Research Topics

Submitted abstracts should identify which ARCC Program area the research is most closely related to:

- Societal Values and Public Engagement
- Health Systems, Services, and Policy
- Survivorship
- Knowledge Translation

Methods

Abstracts submitted for the conference should identify which of the methods used below best describes the abstract being submitted.

- Administrative Data Analysis
- Economic Analysis or Evaluation
- Mixed Methods Research
- Program or Policy Evaluation
- Patient & Public Engagement
- Qualitative Research Methods
- Quality of Life & Preference Elicitation
- Other: Please Specify

Evaluation Criteria for Oral and Poster Submissions

Using a blinded review process, the Abstract Review Committee will review oral and poster abstracts using the following criteria:

- The content of the abstract provides new insight and/or knowledge in the area of applied cancer control;
- The abstract is clear and well organized;
- The proposed presentation is innovative and/or original; and
- The proposed presentation will be of significant interest to conference delegates.

ARCC2020 Student & New Professional Travel Awards

The Canadian Centre for Applied Research in Cancer Control announces the availability of travel awards for ARCC student members presenting at the 2020 ARCC Conference being held in Saskatoon, Saskatchewan, May 25th-26th, 2020. For the first time, we will also offer awards to ARCC members who qualify as "New Professionals" – those who have received their degrees within the last 5 years. Travel awards with a value of up to \$1,000 will be awarded to a limited number of students and new professionals.

Guidelines

To be eligible, an individual must be the presenting first author of an abstract submitted to the 2020 ARCC Conference. Applications for travel awards must be received during the abstract submission period alongside abstract submission. Abstract submission for the 2020 ARCC Conference will be open between December 6th, 2019 and January 31st, 2020. The exact number of awards given will be determined based on available funds and budget requests by applicants.

Notification of award will come with abstract acceptance information in early March. *Please do not register for the conference prior to receiving the final decision to avoid refund charges.*

Eligibility

Applicants must meet the following eligibility criteria:

- A member of the Canadian Centre for Applied Research in Cancer Control (if not already a member, join here);
- A current **full-time** student or recent graduate (degree received between 2015-2019);
- First author and presenter of a submitted abstract; and
- Not a recipient of a Student Travel Award in the previous year.

Application

The completed online application must include:

- Title and submission confirmation of the abstract to be presented at the 2020 ARCC Conference;
- A brief summary of research interests and accomplishments to date;
- A completed travel budget indicating expected expenses and other potential sources of funding;
- Supervisor's contact information (we will contact your supervisor by email to get their support for your application);
- Commitment to providing a brief conference report (1 page) outlining the awardee's experience at the conference; and
- Confirmation of enrollment or recent graduation must also accompany the application form.

Funding Release

Recipients of an ARCC Travel Award will receive a registration code which will provide complimentary registration to the conference. To receive remaining award funds, an awardee must attend the 2020 ARCC Conference and present his/her submitted abstract. After the conference, a completed travel expense claim form together with <u>original</u> receipts (including all boarding passes) must be submitted within 30 days of travel (attention to **Kim van der Hoek, ARCC Centre Manager,** BC Cancer, 675 West 10th Avenue, Vancouver BC, V5Z 1L3). Funds will not be release until the written report has been received.

Adjudication

The 2020 ARCC Conference Committee will coordinate the Student & New Professional Travel Awards. All applications will be adjudicated by two members of the committee and the highest ranked applications, as determined by the average of the two committee members, will receive Student Travel Awards. Conflicts of interest will be resolved by having an additional committee member evaluate the application. Applications will be evaluated using the following three criteria:

- Financial need and relevance of conference attendance to training goals and research interests;
- Quality of abstract submission; and
- Distance travelled to conference by presenter.
